Emily Stearns, Health Improvement Coordinator of Hospital Council of Northwest Ohio (HCNO) – Ready to start the CHIP. Going over the whole CHIP today. Going over the data from your health assessment today. We will go over the key issues at the end of the meeting. 2019-2022 plan. This is the third CHIP for Delaware County.

MAPP (Mobilizing for Action through Planning and Partnership) – We will be using this method for the next four meetings.

The six MAPP phases are as follows:

1. **Organizing**
2. **Visioning** - This is already complete.
3. **Assessments** – The health assessment is complete.
4. **Strategic Issues** – This is what we are going to prioritize today.
5. **Goals and Strategies** – This will take place at the third meeting.
6. **Action Cycle** – Will be moving forward with everything that is in the CHIP at the end of the day.

Emily discussed the “**State health improvement plan (SHIP) overview**” handout. This was released in August 2016. We contracted with the state to work on the SHIP. The Hospital Council of Northwest Ohio has a good understanding of what we need and what the state needs and the outcomes that the state is measuring.

There are **3 priority** topics as listed below. **We need to select two (2) of these per the state.**

- Mental health and addiction
- Chronic disease
- Maternal and Infant Health

There are also **10 priority outcomes** as listed below. **We need to select one (1) outcome.**

- Depression
- Suicide
- Drug dependency/abuse
- Drug Overdose Deaths
- Heart Disease

- Diabetes
- Asthma
- Pre-term Births
- Low Birth Weight
- Infant Mortality.

There are **4 cross cutting factors** as listed below. We need to **select at least 1 cross-cutting strategy** relevant to each selected priority outcome **AND select at least 1 cross-cutting outcome indicator relevant to each selected strategy.** *We need to choose those that align with the state.*

- Social Determinants of Health
- Public Health System, Prevention and Health Behaviors
- Healthcare System and Access

The below KEY ISSUES were identified from community members and stakeholders who provided feedback at the CHA data release event in May 2018. Lori Kannally sent out a Survey Monkey to be sure that all work of our concerns were heard. HCNO combined these together to give us the top key issues. This is what we are going to be basing our decisions on at today’s meeting.

2018 Delaware County CHIP KEY ISSUES (See “*2018 Delaware County CHIP Key Issues*” handout provided by HCNO)

- Mental Health (**13** votes)
- Alcohol Consumption (**8** votes)
- Social Determinants of Health (**6** votes)
- Weight Status (**4** votes)
- Access to Care (**4** votes)
- Bullying (**3** votes)
- Chronic Disease (**2** votes)
- Food Access (**2** votes)
- Tobacco Use (**2** votes)
- Prescription Drug Abuse (**1** vote)
- Dental Health (**1** vote)
- Men’s Health (**1** vote)
- Adult Health Perceptions (**1** vote)
- Immunizations (**1** vote)

Lori Kannally shared a handout “***YRBS statistics that stand out to Youth Advisory Board (March, 2018).***” The results of these statistics were from the 2016-2017 school year. This is a Youth Advisory Board that is being overseen by the HelpLine organization. We will start seeing some of these youth attend our Partnership Meetings moving forward. The items highlighted in **YELLOW** on the report are the statistics that stood out to the Youth Advisory Board. They are also listed as follows:

Weight Status

- ❖ 60% of youth did not have 8 or more hours of sleep on school night (4 respondents)

Mental Health

- ❖ 20% of youth felt sad or hopeless almost every day for 2 weeks or more (6 respondents)
- ❖ 11% of youth had seriously considered attempting suicide in the past year (4 respondents)

QUESTION: *Mental Health and Social Determinants of Health...are they the same thing?*

ANSWER: **We could move the Social Determinants under Mental Health.**

QUESTION: *Alcohol Consumption: Adult current drinkers listed under the “Key Issues or Concerns” column on the “2018 Delaware County CHIP Key Issues” handout—says that 69% of adult current drinkers have an income over \$100,000 (77%) and they are male (74%). Is this correct? I find it interesting.*

ANSWER: **Yes—that is correct.**

QUESTION: *Why are there no questions on opiate use?*

ANSWER: **We do have questions on opiate use. You would have to look at the individual section—it is a very underreported area since we mail the data to home addresses and most addicts would not receive a survey since they usually do not have a home address.**

QUESTION: *We can add opiates under the title?*

ANSWER: **Yes. If we have data to bring to the table we can add that.**

QUESTION: *Do we have data from folks (even agencies) who are working on suicide attempts, etc.? This would be a good piece of information to look at. This could tell us why this is happening and help us to help those people who are suffering from these things.*

ANSWER: **The “Whys” are in the report. What causes you stress, anxiety and depression and want to attempt suicide? Those are questions in there. We do have prescription use in the report. We also have the opiate overdose death report quarterly which is secondary data just because those who are actually using are not likely to fill out the survey. This comes in to play when we go to do the strategies. The Health District has to do some qualitative data, and we might want to get a focus group together and do a root cause analysis. We have representatives from Olentangy School District & Delaware City to look at what is going on in our schools.**

QUESTION: *Opiate issues—back and neck problems, arthritis and chronic pain. These problems could potentially be related as to why they need to take the opiates.*

RESPONSE: **This is definitely something to consider.**

There are so many things in the ACES that can be pulled out and put into different categories.

Delaware County has a Juvenile Traffic Court Crash data statistics for youth and what they were cited for. They asked that we look at that. Per Emily, we can add this into the table.

We will be taking the key issues and ranking them on a scale of 1 to 10.

- Magnitude
- Seriousness of the Consequence
- Feasibility of Correcting

QUESTION: *In lieu of looking at arthritis for chronic pain, could we use “Trauma” instead which would cover substance abuse, arthritis, sexual abuse/sexual behavior and bullying?*

ANSWER: **Yes—We could do some cross-cutting. For example, we will use tobacco as an example. Immediately, I would say that it is an addiction and would categorize it as a Mental Health/Addiction item. However, someone else would say no it causes asthma and it’s a chronic disease, and somebody else is going to say to say that it causes low birth weight and it’s Maternal Health. Social determinants are going to help all three areas. We are used to siloing these ideas because that is how we are funded.**

QUESTION: *As I am taking in and receiving information and as we are getting ready to do the CHIP, what are we looking at this information and then deciding as a community what we are going to do?*

ANSWER: **The rest of the meetings will be focusing on the topics that we decide on today. Strategic and gaps—looking at the information for the community from your perspective.**

Those present took time to look at the data and then voted on the following priorities for the 2019-2022 CHIP:

- ✓ **Mental Health/Addiction**
- ✓ **Chronic Disease**
- ✓ **Cross-Cutting Access to Healthcare, Trauma and Social Determinants of Health.**

Hospital Council of Northwest Ohio will draft the above priorities and bring them back to the next meeting.

Next Steps:

It may also be posted on Facebook. Emily will edit the survey to ask if participants are a Delaware County resident.
